2020 Membership Agreement (rev1)

In consideration of Windsor Essex County Canoe Club permitting you to participate in all club activities

1. **WINDSOR ESSEX COUNTY CANOE CLUB:** In this Agreement, "Windsor Essex County Canoe Club," includes its directors, officers, members, employees, volunteers, contractors and other agents plus the successors and assigns of each of the foregoing.
2. **ACTIVITY:** Any event on or off the water from [April 1, 2020-April 1, 2021].
3. **DISCLOSURE OF RISK:** It is important that you understand the risks associated with the Activity. You acknowledge that such risks include, but are not limited to:
 - Inhalation of water.
 - Contact with contaminated water.
 - Drowning.
 - Collision or contact with individuals or other sporting equipment.
 - Slip or fall.
 - In connection with the transportation:
 - Motor vehicle accident.
 - Mechanical failure
4. **ASSUMPTION OF RISKS:** You acknowledge that you are voluntarily participating in the Club Activities and that you have a responsibility to follow any established rules and direction from those in authority. Failure to do so may result in your being removed from the Activity and prohibited from participating in future activities. You are aware of the risks associated with the Activity and understand that although Windsor Essex County Canoe Club may take steps to provide a safe environment, some risks may be outside its control and other risks may be realized due to human error and negligence on the part of those involved, including representatives of Windsor Essex County Canoe Club. You understand that realization of risks could result in injury to person, damage to property or other loss. If you observe a hazard or unsafe condition you agree to notify those in authority and remove yourself from the situation. You voluntarily and without qualification agree to be responsible for yourself and accept and fully assume all risks associated with the Activity.
5. **DISCLAIMER:** You acknowledge that Windsor Essex County Canoe Club is not and shall not be responsible for any injury to person, damage to property or other loss suffered by you or by any other Activity participant during or in connection with the Activity and due to any reason whatsoever including without limitation negligence, breach of contract or breach of any statutory or other duty of care, on the part of Windsor Essex County Canoe Club.
6. **WAIVER OF CLAIMS:** You hereby waive any and all claims that you have or may in the future have against Windsor Essex County Canoe Club and agree not to sue Windsor Essex County Canoe Club for any injury to person, damage to property or other loss that you sustain during or in connection with the Activity due to any cause whatsoever, including without limitation negligence, breach of contract or breach of any statutory or other duty of care, on the part of Windsor Essex County Canoe Club.
7. **RELEASE FROM LIABILITY:** You hereby release Windsor Essex County Canoe Club from any and all liabilities, costs, sums, damages, expenses associated with any injury to person, damages to property or other loss that you may suffer in connection with your participation in the Activity due to any cause whatsoever, including without limitation, negligence, breach of contract or breach of any statutory or other duty of care on the part of Windsor Essex County Canoe Club.
8. **INDEMNITY:** You agree to indemnify and hold harmless Windsor Essex County Canoe Club from and against all claims, demands, causes of action, suits or other proceedings, liabilities, costs, sums, damages and expenses (including legal and other professional fees), by whomsoever made and whether direct, indirect or consequential resulting from, occasioned by or attributable in any way to your acts or omissions and/or any breach by you of this Agreement. For greater clarity this indemnity is not limited to third party losses and specifically includes the first party losses of Windsor Essex County Canoe Club.
